This is a North Carolina beer, wine, and spirits event that also showcases local crafters. Each week, there will be live music and a local food truck. Our Corolla Cornhole Tournament sponsored by Brindley Beach Vacation & Sales, takes place each week in conjunction to our Corolla Cork & Craft Event. The one-hundred-year-old live oaks, open green lawns, and casual breezes from the Currituck Sound make for a perfect location.

ENTRY FEES

ENTRY MATERIALS

In order to complete the application process, please send an entry packet with the following materials:

1. Completed CRAFTER/EXHIBITOR APPLICATION/AGREEMENT & Corolla Cork & Craft Artist/Exhibitor Rules & Regulations forms.
2. Submit five (5) high quality digital images of your work & one (1) image of your display booth. Return work samples to samantha.payne@currituckcountync.gov. Please include **2024 CC&C Application** in the subject line of your email.

SPACES

Accepted crafters will be assigned booth spaces each week.

Each crafter's application must be reviewed by a jury before being accepted. Please be mindful that there are very limited spaces this year.

CRAFTERS

Crafters must be present to display their own work. Proxy exhibitors are not permitted. Crafters are responsible for their own tents, tables, and chairs & setting up their booth spaces. Work that is not appropriate for a family show cannot be displayed. Any crafter who misrepresents the quality or production of their work will not be allowed to return to future events.

TAX

The current North Carolina sales tax is 6.75% and charging this is the responsibility of the crafter.

Artist/Exhibitor Rules & Regulations

I acknowledge that by signing this Artist/Exhibitor Application/Agreement, I will adhere to the following rules and regulations *(please initial after each)*:

1. The Corolla Cork & Craft event is every Wednesday starting June 12th through September 11th, from 3:00 pm to 7:00 pm. (**NO BREAK DOWN BEGINS BEFORE 7:00 PM.**) _____
2. Set-up time may begin at 1:30PM on scheduled date(s). Artist/Exhibitor will be allowed to drive their vehicle up to their booth during scheduled set-up time and scheduled tear-down time **ONLY**. At all other times, vehicles must remain in the designated parking area. **NO VEHICLES WILL BE ALLOWED ON SHOW SITE DURING SHOW HOURS.** This is to ensure the safety of customers and spectators as there will be excessive foot traffic in the park. Site assignments will be given upon arrival at your set-up time. _____
3. Booth size is 10' x 10'. Tents will need to be staked in the ground. Artist/Exhibitor must provide tent, tables and chairs. Artist/Exhibitor must be able to load/unload their things and set up/break down their booth space themselves. If additional help is needed for set up, the artist/exhibitor is responsible for finding someone to come help. Currituck County Travel & Tourism employees will not be available to help artists/exhibitors set up or break down. _____
4. Trash receptacles are located throughout the park for artist/exhibitors and our visitors' convenience. However, any bulk trash is to be placed in the dumpster located at the public boat ramp area. _____
5. All booths must be manned by the primary artist/exhibitor or designated assistant during show time. _____
6. Photography/Video Consent: Please note that by participation in the event, vendor grants permission of photo and video to be used for the marketing purposes of Currituck County Travel & Tourism. _____

***PLEASE NOTE: Failure to comply with these rules and regulations may result in the termination of Corolla Cork & Craft participation.**
