

**Currituck County Department of Travel and Tourism (Northern Outer Banks) and
BruMate Sweepstakes 2024**

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Currituck County Department of Travel and Tourism and BruMate Sweepstakes 2024 (the "Sweepstakes") starts on 11/21/24 at 12:00 AM ET and ends on 12/31/24 at 11:59 PM ET ("Sweepstakes Period"). The administrator's computer is the official time-keeping device for this promotion.

ELIGIBILITY:

The Sweepstakes is open to legal residents of the United States and the District of Columbia who are 18 years of age or older as of the date of entry. Employees of Northern Outer Banks ("Sponsor"), BruMate ("Prize Provider"), their respective subsidiaries, distributors, affiliates, promotion and advertising agencies, and members of their immediate family (spouse, parents, children, siblings, and their spouses), and persons living in the same household (whether or not related) are not eligible to enter or win. HOW TO ENTER:

Entries generated by script, macro, or other automated means are void. Limit one (1) Entry per person per day for the duration of the Sweepstakes Period. You may only use one (1) email address to enter the Sweepstakes. All Entries become the property of the Sponsor and will not be returned.

RANDOM DRAWING:

One (1) potential Grand Prize winner will be selected in a random drawing on or about 1/7/25 from among all eligible entries received throughout the Sweepstakes Period. Odds of winning depend on the number of eligible entries received. The drawing will be conducted by the Prize Provider.

WINNER NOTIFICATION:

The potential winner will be notified by email. The potential Grand Prize winner will be required to execute and return an affidavit of eligibility, a liability release, and, where lawful, a publicity release within seven (7) days of notification. If the documents are not returned within the specified time, the prize will be forfeited and an alternate winner may be selected. The Grand Prize winner will be issued a Form 1099 for tax purposes and must submit their social security number.
